

Bank of Communications Credit Card Point Links Service Terms and Conditions

General Terms and Conditions

- The Point Links Service (the "Program") is applicable to principal and / or supplementary Credit Cardholders ("Cardholder") of CUP Dual Currency Diamond Card / Platinum Card issued by Bank of Communications (Hong Kong) Limited (the "Bank") and such other cardholders as may be designated by the Bank from time to time.
- 2. Cardholder who wishes to participate in the Program provided by the Bank shall fill in this application form. The Program is applicable in Hong Kong, Macau and Mainland China only
- 3. The information provided by the Cardholder on the application form will be given to Superior Travellers Services Limited ("Point Links") for the provision of the service of the Program.
- The Program is applicable to Cardholder and the accompanying guest(s).
 The service fee is <u>HK\$750</u> per person for using the service of the Program each time. The Cardholder is required to make reservation for the service of the Program for his / her own and the accompanying quest(s) and paid for the related service fee. Reservation for the Program has to make at least 4 working days in advance of boarding to the bank by Fax, otherwise, the Program cannot be used by Cardholder and the accompanying guest(s). The service fee will be debited from the Cardholder's HKD account of principal CUP Dual Currency Diamond or Platinum Credit Card according to the information provided in application form. For any change or cancellation of the Program, the Cardholder is required to notify Point Links by email or fax at least 1 working day before boarding. Either late cancellation or no-show will be considered as fulfilled the service of the Program and thus, no refund will be made for the service fee being charged for the Program.
- 5. The Bank reserves the right to amend the service fee, terms and conditions as well as to vary or terminate the offer of the above Program at any time without prior notice. The Bank accepts no liability for any matters relating to changes or termination of the Program and will not give any prior notice to the Cardholder for such change or termination.
- 6. The services of the Program are bounded by the terms and conditions of Point Links and the personal data provided by the Cardholder to Point Links will not be used for any purposes other than directly related thereto, including but not limited to marketing and promotion. Please visit Point Links website www.point-links.com for details. The service of the Program is owned and operated by third parties, the Bank and Point Links will not accept any liability for any loss incurred by the Cardholder from the Program.
- 7. Service will be varied according to location and are subject to the final decision of the respective airport authority.
- 8. Due to the restrictions imposed by the Immigration and Custom authorities in the airport, the Bank and Point Links do not guarantee the arrangement of service can be made for urgent reservation.
- 9. No person other than the Applicant and the Bank has the right under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong) to enforce or to enjoy the benefit of any provisions under these Terms and
- 10. In case of disputes, the decision of the Bank and Point Links shall be final and conclusive.
- 11. In case of any discrepancy between the Chinese and English version of these terms and conditions, the Chinese version shall prevail.

Complimentary Service of Point Links Terms and Conditions ("The Promotion")

1. The Promotion is only applicable to CUP Dual Currency Diamond Credit Cardholder (including principal Credit Card and the supplementary Credit Card(s)) ("Cardholder"), who has accumulated eligible spending of every HK\$/CNY\$ 150,000 during January 1 to December 31 of the year, the principal Cardholder (not applicable to supplementary Cardholder) can enjoy complimentary service of the Program for 1 time in the following

year, whereas with the accumulated spending amount of HK\$ / CNY\$ 300,000 can enjoy complimentary service of the Program for 2 times in the following year and so on. Each principal Cardholder can enjoy up to 4 times complimentary service in one calendar year (A complimentary service will be counted based on every single trip of each guest). The notification letter of the complimentary service will be mailed to the Cardholder for application on or before February of the following year.

2. If the total no. of usage for the service under the Program by principal Cardholders is less than the entitlement of that year, the unused service will be cancelled and cannot be carried forward to the following year (January 1 to December 31 of each year). In addition, the unused complimentary service cannot be redeemed for cash under all circumstances.

- 3. "Eligible Spending" includes local / overseas retail spending and cash advance by CUP Dual Currency Diamond Credit Card (applicable to principal and supplementary Cardholder) but excludes Octopus Automatic Add Value Service transactions, cash/purchase instalment amount, balance transfer amount, bill payment for payee merchants categorized as a "Banking and Credit Card Services", "Credit Services", "Securities Broker", "Inland Revenue Department" and merchant name "The Hong Kong Jockey Club" via webpage of the Bank, purchase of casino chips, purchase of traveler's cheques, payment of all credit card charges (e.g. annual fees, finance charges, etc.) and any Credit Card transaction's designated by the Bank from time to time.
- 4. For the spending amount made in mainland China by Cardholder, each CNY\$1 spending will be equivalent to HK\$1 for the calculation of the eligible spending of the Program.
- 5. Any fraud and unauthorized transaction as well as the cancelled and refunded transaction will be considered as ineligible transaction which is not applicable to the Promotion.
- 6. The transaction date of the retail spending will be based on Bank's record.
- 7. The entitlement of complimentary service of the Program is only applicable to the Cardholder who maintains good credit status and the principal Credit Card account should remain valid at the time of using the service of the Program. The Bank is at its sole discretion when assessing the Cardholder's credit status and approving the eligibility of using the service for the Cardholder without providing any reasons.
