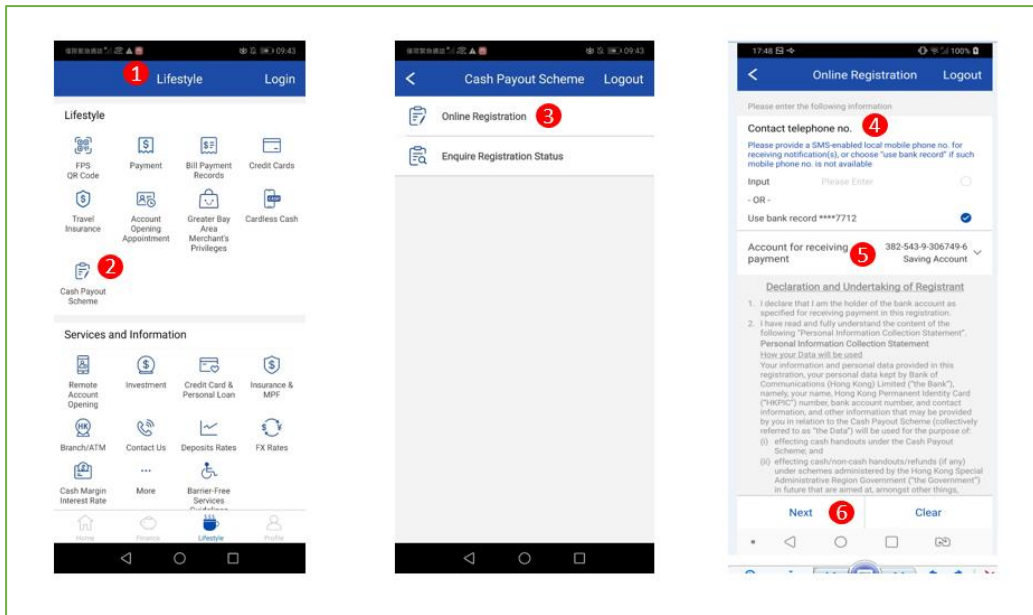

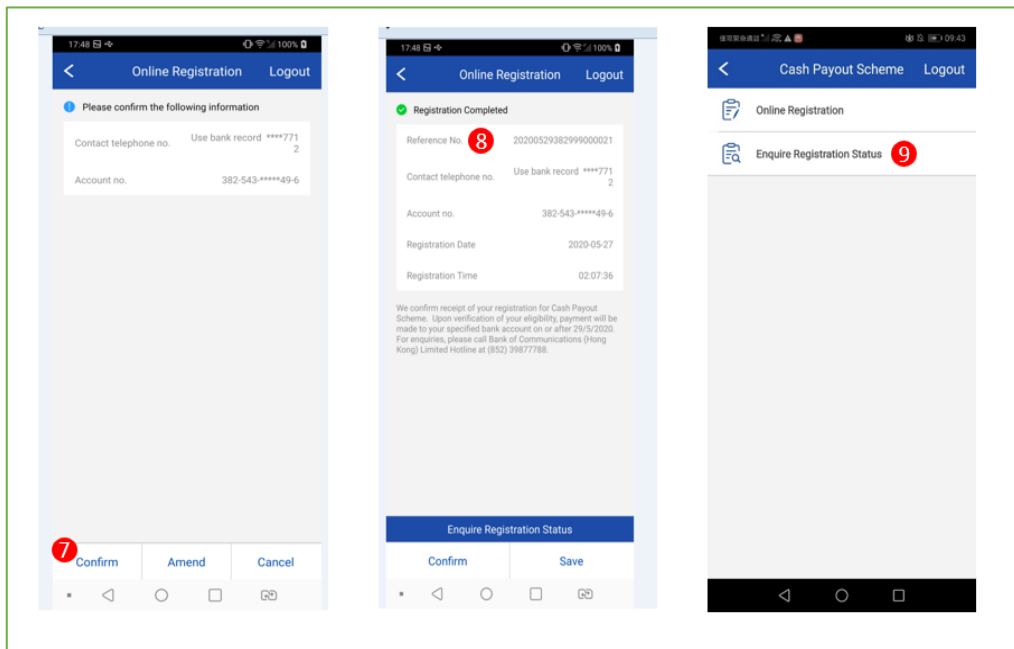


Step 1 – 3: Log in to Mobile Banking, Press “Lifestyle” > “Cash Payout Scheme” > “Online Registration”


Step 1 : Log in to the e-Form located at the Website of the Bank (**Path: Personal Banking > Cash Payout Scheme)**

Step 3: Enter your **Contact telephone no.** for receiving notifications. You can also select to use bank record


Step 4: Enter your HK Permanent Identity Card No. (the first 4 alphabets or numeric)

Step 7: Confirm your registration information

Step 8 – 9: Enter the Verification Code and then press **“Confirm”**



Step 10: Congratulations! Your registration is completed. You can mark down your Reference No.

Step 11: In order to complete the registration process, the Bank will send you an acknowledgment receipt to the contact information you record with the Bank in order to verify your eligibility.

Step 12: You can press **“Confirm”** to leave the page.

According to the Government, Customer who register via **Mobile Banking or Internet Banking** can receive the payment faster than other channels.
